## ORDER SCHEDULING NON-JURY TRIAL

[no pretrial conference]

The attorneys for the Plaintiff and Defendant appeared before this Court on March 11, 2015, for a Case Management Conference, and stated this action is at issue and ready to be set for trial. Therefore, it is

## ADJUDGED that:

- 1. This action is set for Non-Jury Trial on TUESDAY, MAY 26, 2015, commencing at 10:00 a.m. at the Alachua Family/Civil Justice Center, 201 E. University Ave., Room 2002, Gainesville, Florida, or as soon thereafter as counsel can be heard. The time allotted for the Non-Jury Trial is Six (6) Hours. Parties and counsel are hereby directed to appear before the undersigned judge at 10:00 a.m. on Monday, May 26, 2015, unless otherwise notified.
- 2. Not later than thirty (30) days prior to the Non-Jury Trial, Plaintiff shall file with the Clerk of the Court, and serve a copy on opposing counsel, the following:
  - (a) A short statement of the case and the facts on which Plaintiff bases his cause of action;
  - (b) An itemized statement of the special damages Plaintiff expects to prove;
  - (c) If the Defendant has filed a counterclaim, Plaintiff will comply with Defendant's instructions 4(a) and 4(b);

- (d) A schedule of all exhibits and documentary evidence Plaintiff will offer during the trial;
- (e) A complete list of witnesses to be used at trial, together with their addresses and telephone numbers.
- 3. Not later than thirty (30) days prior to the Non-Jury Trial, Defendant shall file with the Clerk of the Court, and serve a copy on opposing counsel, the following:
  - (a) A statement of the facts constituting Plaintiff's cause of action, including damages, which Defendant will admit;
  - (b) If Defendant has filed affirmative defenses, a statement of the facts on which Defendant bases such defenses;
  - (c) If Defendant has filed a counterclaim or cross-claim, Defendant will comply with Plaintiff's instructions 3(a) and 3(b);
  - (d) A schedule of all exhibits and documentary evidence Defendant will offer during trial;
  - (e) A complete list of witnesses to be used at trial, together with their addresses and telephone numbers.
- 4. ALL DISCOVERY PROCEDURES ALLOWED BY THE RULES OF CIVIL PROCEDURE SHALL BE COMPLETED NOT LATER THAN 10 DAYS PRIOR TO THE NON-JURY TRIAL AS WELL AS THE TAKING OF ALL DEPOSITIONS FOR USE AT TRIAL.
- 5. Not later than five (5) days before Non-Jury Trial, counsel shall meet personally and exhibit to each other all documentary and tangible evidence intended to be offered at trial and make a good faith effort to stipulate to their admissibility.

- 6. When appropriate, counsel are encouraged to file memoranda of law before trial and serve copies on opposing counsel and the trial judge.
- 7. The purpose of this Order is to facilitate a fair and speedy trial in this action. Counsel shall communicate with each other in a timely manner and otherwise respond in good faith to this Pretrial Order.
  - 8. All motions must be filed and heard prior to Non-Jury Trial.
